#### Recommendations for June ballot measures Source: CFRW Capitol Update

**Proposition 68:** NO California Parks, Environment, and Water Bond- would issue a \$4 billion general obligation bond, with a 3.5% interest rate over 30 years, bringing the bill to the taxpayers up to \$6.4 billion total.

**Proposition 69:** NO Transportation Taxes and Fees Lockbox and Appropriations Limit Exemption Amendment- states that Senate Bill 1 revenue from diesel taxes will be placed in a "lockbox" and used only for transportation fund purposes. [Supported largely by contractors, unions, and the Democrat Party.-kd]

**Proposition 70:** NO Vote Requirement to Use Cap and Trade Funds Amendment- would require a one-time vote in 2024 by a 2/3rds legislative majority to allocate state Cap and Trade program revenue. [If legislators succeed at securing a two-thirds vote, revenue would begin to fill the non-reserve Greenhouse Gas Reduction Fund, which requires a simple majority vote to use the funds. —*Ballotpedia.com*]

**Proposition 71:** YES Effective Date of Ballot Measures Amendment- changes the date for when voter approved ballot measures take effect from the day after the election to the fifth day after the Secretary of State certifies the election.

**Proposition 72:** YES Rainwater Capture Systems Excluded from Property Tax Assessment- would exclude any new rainwater capture structures from property value tax reassessment from counting as a new structure.

#### **CALIFORNIA**

Some good news. SB 827, a homelessness bill which would have allowed increased density around local transit hubs, died in the Senate Transportation Committee April 18. Most local jurisdictions opposed it due to loss of local control and zoning. Source: leginfo.legislatures.ca.gov.

More good news. State Sen. Pat Bates' (R-Laguna Niguel) bill (SB 1109) on opioid education passed out of the Senate Business, Professions, and Economic Development Committee with bipartisan support. SB 1109 would educate the public, especially those who are involved with youth, by explaining to them the risk of addiction and overdose from prescription opioids. Co-author is Republican DA candidate Summer Stephan. *Source: Sen. Bates' April newsletter*.

Last but not least in the good news column is the growing opposition to "sanctuary state/county/cities (SB 54 which, of course, is already law in California). Several city and county councils, including the San Diego County Board of Supervisors, have passed resolutions reflecting their opposition to sanctuary status. Oppose SB 1424, the Internet: social media: false information: strategic plan, basically fact-checking of Internet news stories. Currently in the Senate Judiciary Committee, this bill would place the government of the state of California in a position of arbiter of truth and would allow them to censor any information that runs counter to the official narrative. This is especially dangerous for activists and dissenters, or anyone who finds themselves questioning authority or exposing corruption.

#### The California "Resistance" in health care

Democrats in Sacramento intend to institute **universal health coverage** in California regardless of immigration status or price tag. They hope now to accomplish this "piece-meal" rather than on comprehensive single-payer legislation which comes with a \$400 BILLION price tag. Bills that have been introduced so far:

## NDATIONS

SB 1108 – prohibits work requirements in Medi-Cal.

SB 910 – Short-term limited duration health insurance, would prohibit the sale in California of Republican-proposed low-cost short-term insurance policies.

AB 2799 – Increases percentage of premium that must go to patient care

AB 595 Health care service plans: mergers and acquisitions would impose greater state oversight of health care providers who want to merge.

The push for these types of bills is led by **Health Access**, a **Health Consumer Advocacy Coalition** consisting of "organized labor, consumers, immigrant advocates and groups such as Planned Parenthood." See health-access.org. The coalition advocates a **state-only individual mandate**, **compelling people to buy health insurance**. Another goal is to **expand coverage to undocumented immigrants** up to age 26 and the elderly. California already provides healthcare coverage for all children, 225,000 of whom are undocumented. *Source: CalMatters.com* 

#### A review of CFRW's April 20 Capitol Update . . .

**Oppose AB 2943**: Makes it a fraud to offer help, information, or materials to adults questioning their gender or sexuality.

**Oppose AB 1745:** Bans ALL gas-powered vehicles by 2040. In Assembly Transportation Committee, sponsored by California Assemblyman Phil Ting, Bay Area Democrat. Interestingly, he has cancelled the budget hearing on this bill.

#### **WASHINGTON**

Major IRS reform is underway in DC, guided by the House Ways and Means Committee's Kevin Brady (R-TX). And . . . President Trump has signed HR 1865, the Allow States and Victims to Fight ONLINE Sex Trafficking Act. #### Is it simply a Matter of Semantics?

Semantics as in using the term, "undocumented immigrant" is a term created by the Left and used by organizations to distort the truth. Even Merriam-Webster Dictionary describes semantics as "language used (as in advertising or political propaganda) to achieve a desired effect on an audience".

Improper entry into the United States is a crime. It is a misdemeanor punishable by no more than 6 months in jail and up to \$ 250 in civil penalties for each illegal entry. Among other things, the First Amendment of the United States Constitution and the California Constitution protects the freedom of speech for all citizens. However, recently college and university campuses in our state have failed to protect our students' right to the freedom of speech, as current events have shown alarming trends on public campuses.

Our students are our future leaders and letting all students be able to express their rights on campus is crucial to their development. After all, public universities are "peculiarly the marketplace of ideas," as the United States Supreme Court once called them.

This legislative year, I introduced Senate Bill (SB) 1388—the Forming Open and Robust University Minds (FORUM) Act—with the goal of protecting the rights of all people in places of higher education, including students, student groups, and belief-based organizations. This bill would allow them to engage in lawful expression without disciplinary action, along with removing "free speech zones" on campuses which generally restrict speech to a small segment of campus. Virginia, Missouri, Arizona, Colorado, Tennessee and Utah have already banned campus free-speech areas.

SB 1388 would require that students be educated regarding their free speech rights and responsibilities and it would allow alleged victims to bring a cause of action for violation of their free speech rights. It also requires that administrators and campus police understand their duties regarding free expression on campus.

Most importantly, SB 1388 empowers legislators to hold universities accountable by requiring each institution to report on free speech issues prior to the legislature's appropriations process. #### Poison in our streets

Our young people are facing dangers that many parents aren't aware of. Fentanyl, a synthetic opioid that is 30 to 50 times more potent than heroin, can be disguised as over the counter medications like Xanax or aspirin, but kids have been killed who unknowingly take them.

This session I introduced AB 3105 to increase penalties for selling fentanyl, a controlled Schedule II drug. Trafficking in Schedule II drugs currently results in county jail sentences of 3 to 5 years.

Under my bill, the amount of fentanyl needed to trigger prison is lowered, recognizing that it only takes a small amount to kill or injure someone. Violators would be sentenced to 10 years to life in prison for trafficking in 20+ grams of a substance containing fentanyl -- the sentence would increase to 20 years to life if serious bodily injury or death occurs. If the drug trafficker has two or more felony convictions involving a controlled substance, they'd get life without parole.

The fentanyl problem has exploded in recent years. Our young people especially are at risk, because they may unsuspectingly take a pill from a friend or acquaintance that looks like Advil, but in reality was bought off the street and contains fentanyl. With a death reported every 19 minutes, drug overdose is the leading cause of accidental death in the United States. Fentanyl, the latest poison on our streets, is adding to that sad statistic.

As your Assembly representative, I will continue working to break the cycle of drug trafficking and abuse that devastates families and cuts short so many lives.
