Jan Caldwell has represented both the FBI and Sheriff's Department, explaining major crimes, debriefing disasters and issuing public safety warnings through our TVs, newspapers and radio.

She started her FBI career at 19, after graduating from Orange Glen High School in Escondido. She heard a radio ad selling a tantalizing, exciting career with the FBI. She applied and was hired as a clerk in the bureau's San Diego office.

She worked graveyard shifts and attended college classes during the day, graduating with a bachelor's degree in clinical abnormal psychology.

After college she applied to become a special agent and went to the FBI Academy in Quantico, Va., in 1980. She became San Diego's fifth female FBI agent.

In 1993, after she'd been in San Diego working drug and asset forfeiture cases for a few years, then-Special Agent in Charge Bill Esposito asked Caldwell if she'd like to become a spokeswoman.

"I said, 'Not at all, thank you,'" Caldwell recalled. "Not that I had any disdain for the media. It's just that I had known agents who had been fired for saying something they shouldn't have. The bureau is very careful — and they have to be — in what they say."

She was assigned the role of media coordinator anyway.

With virtually no training on her new job, Caldwell's first foray into the news came quickly with the drug cartel shooting of Roman Catholic Cardinal Juan Jesus Posadas Ocampo at the Guadalajara airport in Mexico. The cardinal had died during a bungled attempt by the Arellano Félix Organization to murder Sinaloa frontman Joaquin "El Chapo" Guzman.

Her first on-camera interview was live on KUSI with reporter Doug Curlee in 1995, about the Oklahoma City bombing. "I lived to tell about it," she said with a smile.

Then Bill Gore came to San Diego to head the FBI office in 1997, just before San Diegan Andrew Cunanan went on a murderous rampage that included killing fashion designer Gianni Versace.

On Sept. 11, 2001, Caldwell handled an onslaught of media once it was realized that two of the hijackers had lived and learned to fly here. The volume of calls was so heavy it shut down the switchboard, she said.

When envelopes with menacing white powder began showing up at TV stations and government offices in anthrax scares, one came to the FBI in San Diego. It was addressed to another female agent but had Caldwell's home address on the return label. That, and a few death threats, "got my attention," she said.

She retired from the FBI in 2006 and became the spokeswoman for the Sheriff's Department, where she worked until retiring in 2016.

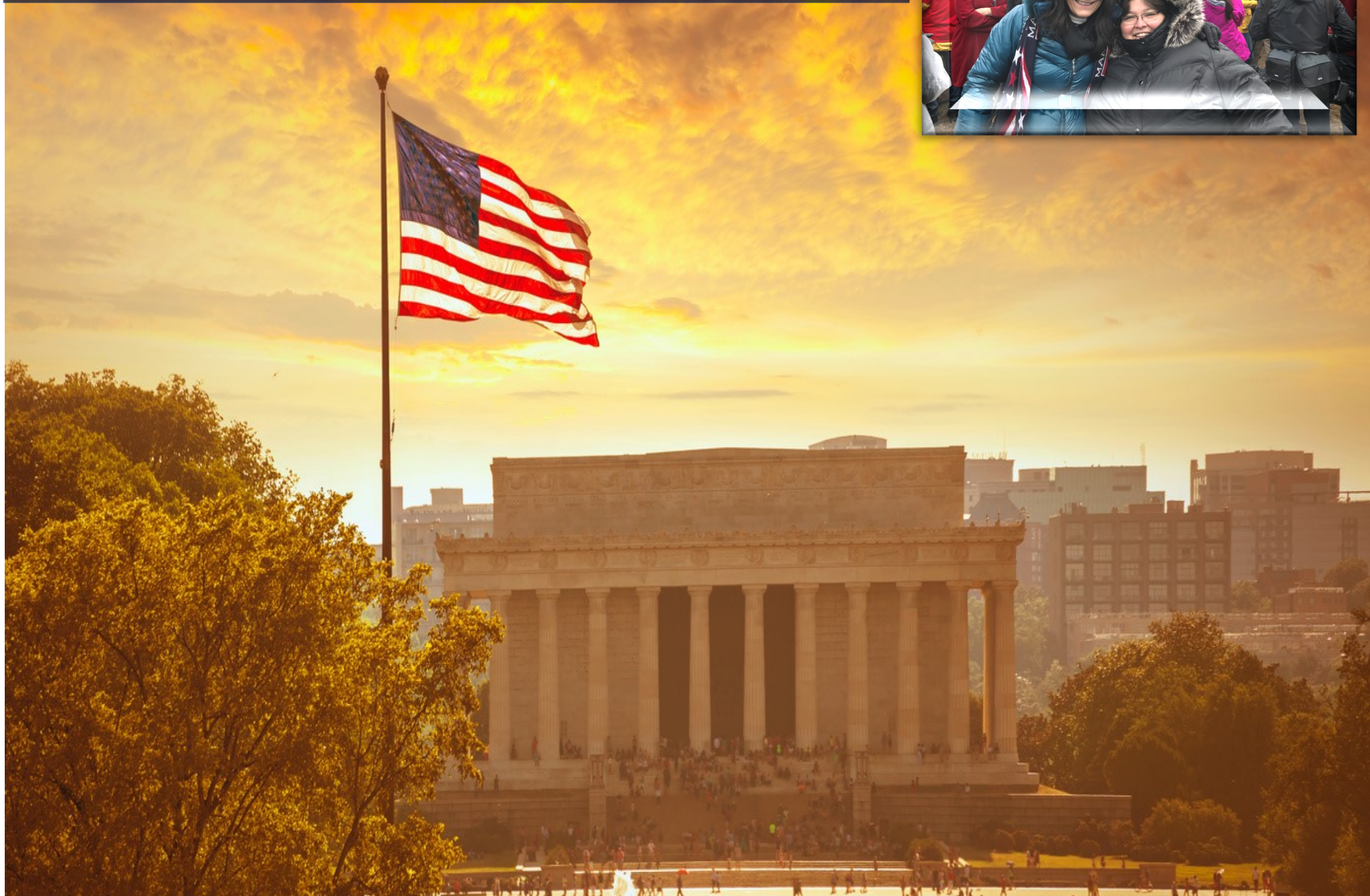
Our own club was founded in 1961. Our club has been recognized for service to our community in humanitarian deeds as well as political involvement.

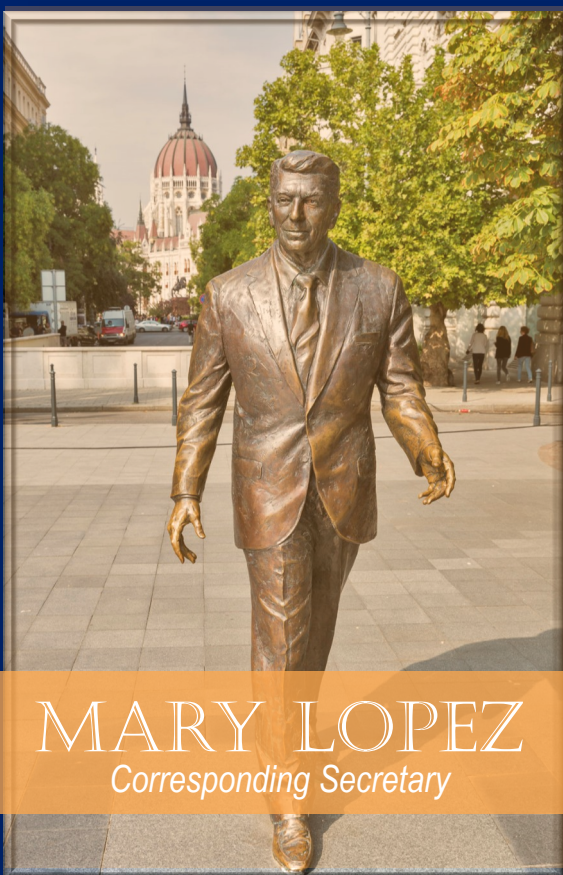
Our women are active in religious groups, humanitarian groups, and in elected and appointed offices within the government, the Republican Party, and the Federation.

ASSEMBLY BACK TO WORK

Assembly Speaker Anthony Rendon has appointed me to serve on six committees for the new two-year session.

I'm excited to be re-appointed to Health Committee and address man issues important to my district, including access and affordable health insurance, Medi-Cal and Denti-Cal, clinics, mental health treatment and long-term care facilities.

My experience as a city councilmember helps as Vice Chair of Local Government Committee, involving land use, housing, infrastructure financing, charter cities, state mandates and other issues with major local impacts here at home.

With five gaming of eight total federally recognized Tribal Governments in the 75th Assembly District, I am re-appointed to the Governmental Organization Committee, with responsibilities over Indian gaming, horse-racing, gambling, tobacco, public records, emergency services and natural disasters.

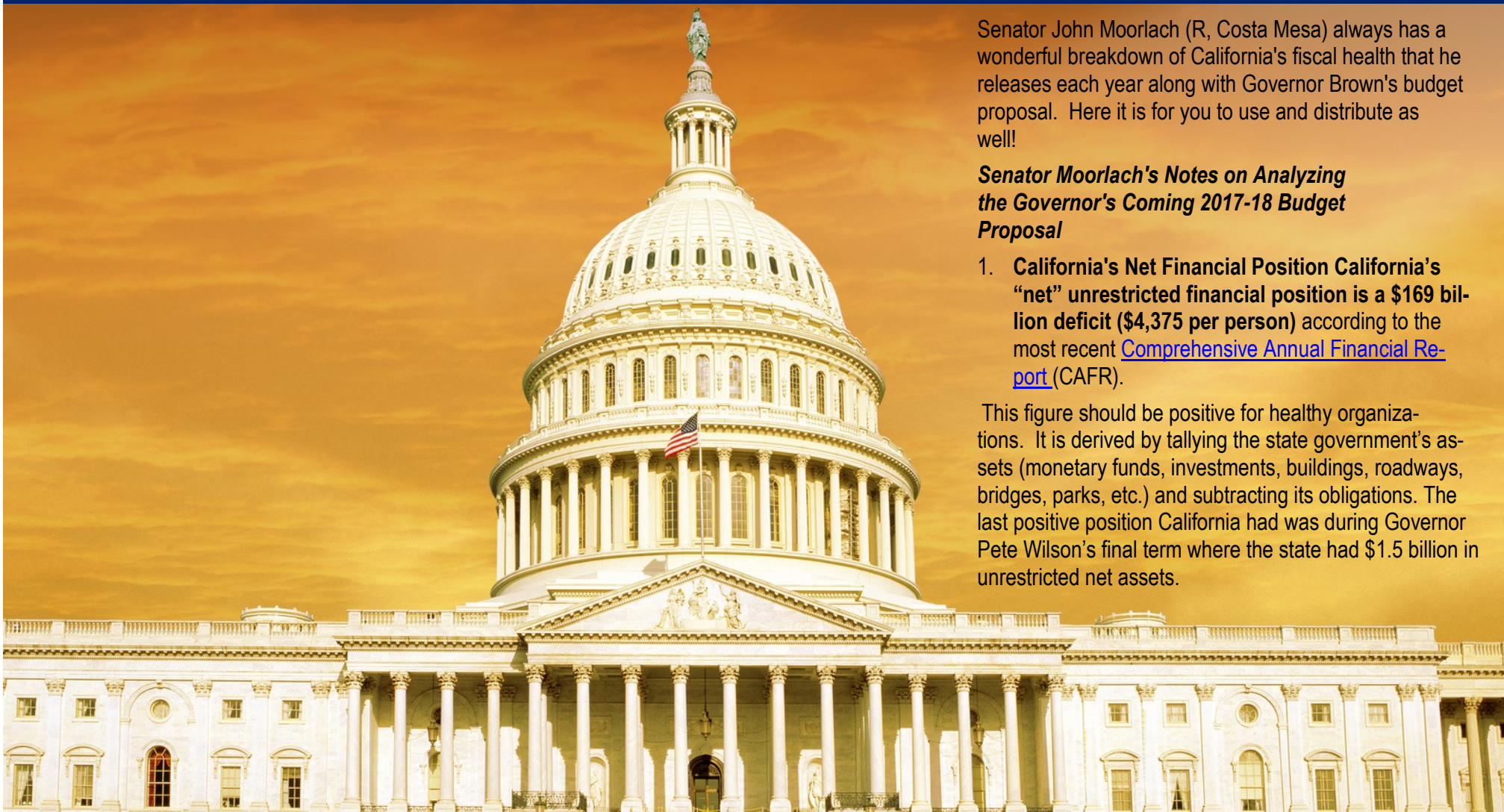

Senator Moorlach's Notes on Analyzing the Governor's Coming 2017-18 Budget Proposal

1. **California's Net Financial Position** California's "net" unrestricted financial position is a \$169 billion deficit (\$4,375 per person) according to the most recent [Comprehensive Annual Financial Report](#) (CAFR).

This figure should be positive for healthy organizations. It is derived by tallying the state government's assets (monetary funds, investments, buildings, roadways, bridges, parks, etc.) and subtracting its obligations. The last positive position California had was during Governor Pete Wilson's final term where the state had \$1.5 billion in unrestricted net assets.
