## Meet and Hear Candidates At Our May 25 Meeting



**Paulette Donnellon**, a voting Member of Escondido RWF since 2012, is a candidate for the San Diego County Board of Education, District 4. She has over 25 years of experience working with technology in education. She has held positions with Toshiba, Okidata, American Power Conversion and Intelligent Papers. Currently, she is the Director of Partnerships for Gooru, a non-profit organization, whose mission is to honor the human right to education. Gooru has created a free learning navigator for teachers to organize web resources into lessons so that students can learn their way. Paulette is very active in the education and nonprofit communities. She has served as a member of the Association of Teacher Educator's Standing Committee on Technology and the Future of Teacher Education, as a board member for the College of Borrego and as President for the Escondido Education Foundation. In 2012 she was elected to the Escondido Union School District Board of Education. She served as the President of the board in 2015. In addition to her technology and volunteer background, Paulette has served 9 years in the U.S. Army and was deployed during Desert Storm. Paulette grew up in Escondido, CA, and attended Escondido Public Schools. She is married to her husband John Donnellon and they have 2 boys, Michael and Kevin. In her spare time, Paulette enjoys baking and spending time exploring the desert.



**Paul Ware** is currently a Federal attorney with the Department of Justice (2009-present) providing legal analysis and recommendations concerning violent crimes to Assistant United States Attorneys and federal law enforcement agencies and officers. Represents the United States in administrative hearings concerning firearms and explosives licensees.

## **“What the Constitution Means to Me” by Taylor Menconi** **2016 Mousel Scholarship Award Winner**



Exhausted, I pressed my forehead against the bus window, attempting to sort through memories and put everything I experienced into retrospect as we passed shack after shack. The sun had almost completely set and my

heavy eyes struggled to stay awake, wanting to soak up every last moment. I saw locks on each window, gate, and door. I saw homeless children performing fire tricks in the street. I saw girls lying in the dirt. I saw policemen pushing an old woman after she stole a vegetable. My heart shattered.

I am not sure why, but for some reason, I was born within the borders of the United States. I am an American citizen. When I returned last summer from Ecuador, I had a new pair of eyes that gave me a fresh perspective on the things I took for granted. My new vision resulted in an even larger culture shock coming home than when I arrived in Ecuador. I realized how blessed I am to live in a roofed house with employed parents and more than enough food for three meals a day. Even though my parents are stressed over our mortgage, bills and college for their three children, I am still able to receive a good education. I have access to resources in my country that allow me to have the potential to attend a prestigious university and pursue a chosen career. I have so many more opportunities than most people will ever have. The American Dream is mine to grasp, but my experiences reinforced the belief that it is really so much more.

In 1787 the American Dream was first conceived with the construction of the Constitution during the Philadelphia Convention. Its elegant yet humble simplicity was made known to the world for years to come, establishing small national government and fundamental laws. To ensure the inalienable rights of citizens, the anti-federalists demanded a Bill of Rights to protect the God-given freedoms of individuals, something the Declaration of Independence also promised.

Without the Bill of Rights, the Constitution may not have been ratified and natural rights may not have been enumerated. The founding fathers knew they were not infallible and allowed for amenability of the Constitution, but were nonetheless convinced that what they wrote was the cornerstone for making America stand apart. At the core of everything the U.S. does, that Supreme Law of the Land was intended to be our bedrock. When it is ignored, shortcuts are made that checks and balances were intended to prevent, power is given to government and taken from people, and citizens become fragmented. Thus, with nothing to stand upon, the U.S. will slowly but surely lose its distinct unity, and become increasingly like the rest of the world.

In the United States today, the Constitution has been consistently undermined. Presidents have made executive orders that bypass the Legislature, overstepping and taking power from the representatives in Congress, and consequently, the people. Citizens, then, easily disconnect from our common values as Americans. Affirmative action, for example, intends to value one group of the population over another, which is a violation of the Equal Protection clause of the 14th Amendment.

Though the Constitution intended to create “a more perfect union” under the States, it is not the case. Most Americans claim to love the Constitution and have a basic understanding of it, but even those in power seem to forget its purpose. We love the American Dream and what it can provide us. We love that it can allow us to get rich, live comfortably and have a family and business without excessive interference of government. We love that it can grant us the simple joys in life. All these things are because of the Constitution, yet our government, supposedly for the people and by the people, wants to lean toward the ideals of other nations.

While in Ecuador, I learned from locals that their third-term elected president won a new Constitution seeking to establish internal stability, as he strengthened the country’s relations with Iran, Russia, China and Venezuela. Although

proponents of socialism believe it provides equality for all citizens, I saw the reality of it when I travelled there. Because it has been proven throughout history, the founding fathers understood the inborn attraction of power and therefore wrote the U.S. Constitution so that human nature would be governed in the face of intrinsic and extrinsic pressures, feasibly leading to the country’s unyielding steadfastness.

The U.S. Constitution means that human nature ought to be more strictly governed than the affairs of the American people. In a world where people inherently desire power, the necessary evil of government needs a clear limit of power. Each succeeding president has been allotted more power and it has not been reduced due to the natural inclination of man, as history confirms. Regardless of the motivations of government, it is absolutely crucial that elected officials return to the Constitution to seek leadership and direction, and are held accountable from the everyday American people who theoretically run the nation.

Despite the quality of life the Constitution so enables, there are places where the principles of the U.S. Constitution do not exist. So for me, instead of being satisfied with my own life, the Constitution also ultimately means that I get to live and die for greater things than myself and fight for others who cannot fight their own battles. Although I cannot bring democracy or a Bill of Rights to every place that does not have the same values the U.S. does, I understand firsthand what it is like to live without constitutional rights. As a result, I desire to live out the ideals the Constitution holds by establishing justice in other parts of the world, insuring tranquility among cultures, promoting general welfare, and securing blessings of liberty to not only Americans, but others as well.

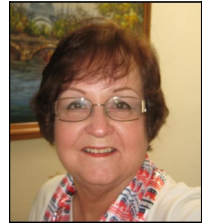
### VOLUNTEERS TO REGISTER VOTERS AT ESCONDIDO CITY HALL MONDAY, MAY 23

## LITERACY—THE NFRW RED SHOE BOOK CLUB



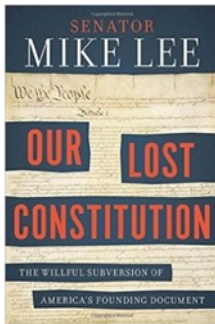

### **"OUR LOST CONSTITUTION"** by Senator Mike Lee

In the foreword to *Our Lost Constitution*, Senator Mike Lee explains that he wants to tell us a different story of our nation's founding than the one we learn in school, and indeed the story he relates is more compelling than the standard histo-

ries we are used to.

He brings to life the frustrations and hard-fought successes behind the "miracle in Philadelphia", the Constitutional Convention of 1787 where Madison, Hamilton, Washington, Franklin and their fellow delegates struggled against heavy odds to replace the Articles of Confederation with a durable Constitution. Senator Lee brings to vivid life important leaders such as James Madison, the man a colleague said was "no bigger than a piece of soap", but whose powerful intellect was instrumental in the formation of the Constitution; and Benjamin Franklin, whose genius at compromise (and convivial dinner party) pulled the delegates together at a critical juncture.

Senator Lee goes on to show us how, over the centuries, straying from what he calls the "lost clauses" of the Constitution has jeopardized our precious liberty. He

convincingly illustrates how many of the issues we struggle with today, such as NSA data collection, Obamacare and the delegation of powers to unelected bureaucrats at federal agencies, would not exist if our elected leaders and the Supreme Court practiced fidelity to provisions such as the Origination Clause, the Legislative Powers Clause, and the other crucial protections built into the Constitution through the hard-fought efforts, foresight and wisdom of our Founders.

Senator Lee doesn't just talk about what we're losing; he offers concrete steps on how we, as citizens, can reclaim the Constitution. His useful suggestion for our current election year: we should ask every candidate for federal office to explain the purpose of the federal government. The answer will tell us much about the candidate's understanding of the Constitution and help us decide whether or not we want that person to represent us in Washington.

This is an important book that will be enjoyed by everyone who views our Constitution as the precious foundational document at the root of American exceptionalism, but it should also be read by those who may not give much thought to the Constitution but are dismayed by the direction of our country and want to understand why we're facing our current dilemmas and what We the People can do about them.

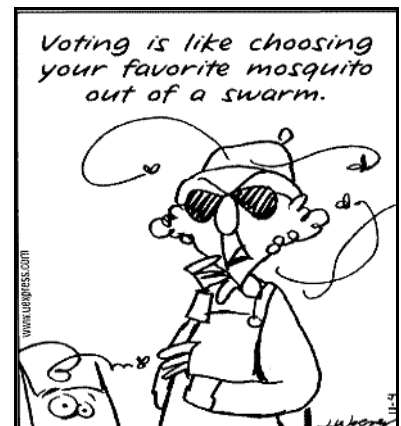

## HOUSE

Rep. Peter Roskam (R-IL) has introduced a bill [HR 5053] to **stop the IRS from collecting donor details of tax-exempt groups**. The bill passed the House Ways and Means Committee in late April. Progressive groups, such as Democracy 21 and Public Citizen, say that IRS Schedules Bs are important to protect against foreign donations to tax-exempt groups; however, there is already a blanket ban on foreign money spent to influence U.S. elections.

The real progressive interest in donor disclosure is to use the information as a political weapon. Leaked selectively, and as we know much government data is sloppily handled, donor lists with addresses and other information can be used to suppress the speech of political rivals. Source: *wsj.com*

## 9/11 Families v. Saudi Arabia

**News Flash! Senate Bill 2040** (HR 3815) **Justice Against Sponsors of Terrorism** (Schumer, D-NY and Cornyn, R-TX) allowing victims of the 9/11 terror attacks to sue Saudi Arabia passed the Senate on Tuesday, May 17, by unanimous consent.

President Obama has threatened to veto the bill; Saudi Arabia is threatening retaliation. Schumer said he wouldn't uphold a veto, and expects that most senators wouldn't, either. "I think we easily get the two-thirds override if the president should veto," Schumer said. Sen. [John Cornyn](#) (R-Texas) said he and Schumer are talking with leadership in both parties to get an "expedited" vote on the bill in the House. Source: *thehill.com*

## Pension Bailouts for Teamsters

Treasury Department "Special Master" Kenneth Feinberg this month blocked Central States Pension Fund (Teamster workers' and retirees' pensions) from using a 2014 law to save itself and with it the Pension Benefit Guaranty Corporation which is precariously close to failing. (The 2014 law allows endangered pension plans discretion to pare benefits under certain careful restrictions.) Instead of a solution, this blockage will surely hand this problem to the Congress (taxpayers) and the next administration for a bailout; indeed **Sen. Bernie Sanders** has already sponsored a bill to Congress to bail out this fund and others in his Keep Our Pension Promises amendment. Source: *wsj.com*

## Court Decision Affecting Obamacare

**May 12 the US District Court in Washington DC sided with the US House of Representatives, who brought the suit) in ruling that the Obama Administration unlawfully funded parts of Obamacare with-**

This will go to appeal but stops for the moment the payment of premiums (**subsidies to private insurers**) through Obamacare. U.S. District Judge Rosemary Collyer ruled that the administration cannot spend billions of dollars in federal funds to provide subsidies without the approval of Congress.

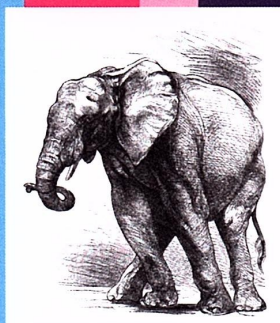

#### **Punishing corrupt politicians is important, but Prop. 50 isn't the way to do it**

Proposition 50, the sole measure on the June 7 ballot, grew out of an extremely bad year for the California Senate.

It was 2014, and one veteran lawmaker — Sen. Roderick D. Wright (D-Inglewood) — had been convicted in January of voter fraud and perjury for lying to voters about living in his district. In February, authorities indicted Sen. Ronald S. Calderon (D-Montebello) on charges including tax fraud, accepting bribes and money laundering. Then in March, Sen. Leland Yee (D-San Francisco) was arrested on suspicion of soliciting bribes, arms-trafficking and racketeering.

There was a strong sense that these legislators needed to be removed from their official lawmaking duties, either by suspending them until their cases were resolved or expelling them outright. In the end, the Senate voted to suspend all three, though many legislators were unhappy that Wright, Calderon and Yee would continue to draw a paycheck and receive benefits until leaving office or until their cases were resolved. Then-Senate President Pro Tem Darrell Steinberg explained at the time that the state Constitution doesn't allow members to suspend one another without pay. To mollify the critics, Steinberg persuaded his colleagues to propose a ballot measure that would explicitly authorize the Legislature to suspend members without pay on a two-thirds vote.

Unpaid suspension could conceivably be used for political reasons. Many legislators come from modest means, and losing their legislative paycheck could force them out of office.

The three problematic legislators are long gone from the Capitol, either resigned or termed out of office. Yee has since been convicted and sentenced to five years in prison. Calderon's case has not yet gone to trial, but he has been termed out of office. Yet the proposed constitutional amendment, Proposition 50, is still on the June

ballot, like a hangover still lingering from that dark period.

The proposition may sound appealing — why should legislators continue to get paid while under investigation for criminal acts? — but voters should reject it. One reason to do so is that it would violate the right to due process afforded to every citizen of this country, including politicians who are behaving badly.

The proposition also would not limit the use of this punishment to elected officials who are accused (or convicted) of breaking laws. The new language simply adds the possibility of suspension without pay to the section of the state constitution setting out how the Senate and Assembly may police themselves, and lays out what suspension means in practical terms. It doesn't set any criteria for what transgressions would justify this punishment, and there's no mechanism to ensure that it would be applied consistently. Indeed, the cases of Wright, Yee and Calderon make that point. Thought Wright was convicted in January, it wasn't until March, after Yee's arrest, that he was suspended along with the other two.

Another problem is that unpaid suspension could conceivably be used for political reasons. Many legislators come from modest means, and losing their legislative paycheck could force them out of office.

The opponents of this proposition, who include Sen. Joel Anderson (R-El Cajon), worry that it would give lawmakers another reason not to expel members who really should be removed from the Legislature. Anderson, the sole senator to vote no on the suspensions in 2014, had pushed for Wright to be expelled shortly after his conviction, but Steinberg would not allow the Senate to vote on that proposal. The result was that a convicted criminal continued to receive a paycheck, but because he was suspended, the constituents of his south Los Angeles district went unrepresented in the Senate for months.

Notwithstanding 2014, it is rare that elected state officials are charged with bribery, voter fraud, gun-running or other crimes so serious as to merit job sanctions. If they do, legislators already have adequate tools at their disposal: expulsion, suspension and censure.

## Rep. Duncan D. Hunter: Integrating Women Into Combat Specialties Is Not a Joke, It's Serious

There is nothing funny about combat. Anyone who has ever been in the fight will tell you that war is not a joke or a subject for a punchline.

This was the case last week when the liberal media and several late night talk shows made light of an amendment I proposed to an annual defense bill to force a debate on the merits of integrating women in the infantry and special operations and therefore requiring they register for the draft. It was branded as a "joke amendment," by one late night show host. Another called it a "sarcastic" exercise.

Clearly it struck a nerve.

Good, I say. It is about time that liberals take an interest in our military, even if for just a moment to defend the social experimentation that is being imposed on the services. In doing so, however, they egregiously misrepresented the basic substance of the argument on whether women should or should not be required to submit for draft registration.

Women have long been exempt from the draft—and for right reason. In 1981, a challenge to the exception was heard by the Supreme Court, which determined that the practice of registering men only for the draft was constitutional. The rationale was that since women were excluded from ground combat, they should not have to register. Congress agreed and subsequently reaffirmed the exception.

More than 30 years later, the Obama administration turned things upside down when it demanded that women be integrated into all combat specialties, including infantry and special operations. The Marine Corps resisted, arguing that all specialties can be opened with the exception of the infantry, which is assigned the duty of finding and killing the enemy, often through close-quarter combat. The Marine Corps even produced an independent and peer-reviewed report to make their case. The report was ignored.

Not long after, during a Senate hearing in February, both the Commandant of the Marine Corps and the Army Chief of Staff endorsed the idea of women registering for the draft. They conveyed a point similar to what the Supreme Court concluded decades earlier. If women are in fact integrated in combat roles, then they should be eligible for the draft. The Secretaries of the Army and Navy said the issue should be discussed.

The time to have that discussion is now.

The services have already begun integration and it will take up to three years until it is final. Before Congress decides whether to permit full integration to go forward in this time, it must also consider every issue—good or bad—that comes with the Obama Administration's desire to fully integrate infantry units and special operations.

Having served in ground combat as a Marine Corps officer, including a tour in Fallujah, Iraq, I am more than willing to be the person to force the conversation, because if I do not, who will? Will the late night talk shows do it? Not a chance. How about liberal talking heads in the media? Keep dreaming.



When I proposed my amendment, I even did so with the intention of voting against it. It passed by a vote of 32-30, with Democrats on the Armed Services Committee uniting in support. They are now on the record as upholding draft registration for women—I am not, along with 29 others who voted no.

Let me be clear: I don't support women in the infantry or special operations, nor do I support women registering for the draft.

One of my Democratic colleagues even referred to the amendment as a "gotcha" effort. That was hardly the case. The issue of integrating women in combat specialties is far too serious to ignore. So are the consequences of opening these specialties and the draft is one of those consequences—like it or not.

Liberals have even suggested there was some grand strategy in order and the amendment backfired. Not even close to true. The strategy, if one existed, was to force members to go on the record and state a position, rather than hide. In Congress, we are asked to make tough decisions all the time and we must embrace that responsibility. Though it is far from certain what will happen to the provision. In all likelihood, it will be removed from the bill through the floor process or during House-Senate negotiations.

Worth noting also, Representative Charlie Rangel once voted against legislation of his own that reinstated the draft during the wars in Iraq and Afghanistan. His legislation was strongly opposed in a

floor vote. To his credit, he succeeded in forcing a debate that was worth the time and attention of the American people.

It is a fact that women have been placed in combat situations through the wars in Iraq and Afghanistan, but that is much different than serving in the infantry or with a special operations unit—especially in a conventional setting, which is unlike the counterinsurgency and counterterrorism missions of the last 15 years. Of course, there are surely some women that can meet or exceed the standards, though Congress will need to consider whether that should necessitate accommodating such a shift in military culture and mission effectiveness.

Something tells me that the late night hosts and liberal media

pundits who have found humor in this issue have never served a day in their lives—or even given the idea thought. The military is not for everyone. But they do a great disservice to all of our military men and women by trying to ignore the effects of the Obama Administration's decision making.

Count me as one Marine Corps veteran in Congress who won't let that happen.

### **"California's Housing Crisis"**



California is the nation's largest state, with a population estimated at just over 39 million. The availability of housing has not kept up

with population growth.

As is so often the case in California, government intervention has been counterproductive, resulting in an inadequate supply and skyrocketing housing costs, along with a lack of sustainable water and energy reliability.

Programs that subsidize housing cannot begin to meet the massive

backlog that has been created. But there is an obvious solution to this problem – less government with fewer, more streamlined regulations that will increase the supply of housing and decrease costs.

Fees imposed by various state and local jurisdictions are another problem. For example, regulations require one "low cost" home for every 10 built, or payment of a fee which can amount to thousands. Storm water compliance can cost up to \$25,000 and hooking up to water and sewer lines can add another \$20,000 – per home!

California's huge unmet housing demand should lead to developers lining up to fill the need. That has

not been the case in recent years. In San Diego County alone, we need about 12,000 new units per year to meet demand. While local construction once met or exceeded that number, the county is short approximately 50,000 housing units over the past 10 years.

Stringent regulations and excessive fees make expanding our housing stock extremely difficult. This crisis will worsen and costs will continue to rise as long as government continues to hinder the state's once thriving housing industry. Until these factors are resolved, the Golden State simply won't be golden for millions of people.



## SENATOR JOEL ANDERSON

I am excited to share with the Escondido Republican Women, Federated members that I am co-authoring SB 1457 with Senator Morrell to provide an important opportunity for public high school students in our community to receive school credit for religious instruction.

Under existing law, students may be excused with the consent of their parents or guardians to participate in "released time instruction." This released time allows students to leave during public school hours to participate in religious and/or moral instruction. This provides students with the enriching opportunity to receive small aggregates of private education, at no cost to parents or schools.

SB 1457 authorizes school districts to adopt a policy that allows a high school student to earn two elective

credits toward their graduation requirements for the completion of released time instruction. It also removes a barrier under current law that limits released time instruction to four times a month.

Please consider sending a letter of support for SB 1457 to my office so that together we can make a strong showing of support for this proposal with my colleagues in the legislature.

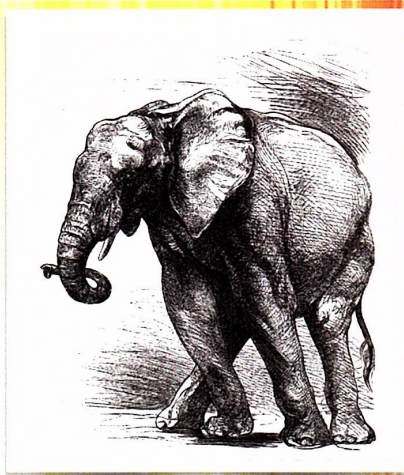
